



Built by Peter the Great and designed by Italian architects, St. Petersburg is truly a magical metropolis with imperial flair. #### JUL 12: TALLINN, ESTONIA Arrive 8am–Depart 5pm

Culturally fascinating and beautifully preserved, Tallinn is the result of avant-garde style fused with medieval charm. Red-roofed homes line cobbled streets and 14th-century churches are ornamented by powerful spires. #### JUL 15: GDAŃSK (GDYNIA), POLAND Arrive 7am–Depart 3pm

Castles and monuments abound in the seaside town of Gdańsk, one of the oldest and once one of the most important cities in the Baltic. Housed in the old medieval quarter are the lovely Golden Gate, the enchanting 15th-century Artus Court, beautiful St. Mary's Church and Oliwa Cathedral, renowned for its massive pipe organ.
