**RESPONSIBILITY:** GN is responsible to you for arranging all included transportation, accommodations and other services. GN and the sponsoring association are not responsible for personal injury, property damage or any other loss, claim or damage arising out of either in whole or in part, acts of God, weather, labor strife, government actions, mechanical breakdowns, war-like acts, terrorist activities or other causes reasonably beyond the respective control of GN and the sponsoring association. GN and the sponsoring association are not responsible for incidental or consequential losses or damages.

**AIR TRANSPORTATION:** Airfares are capacity controlled and may have restrictive terms and conditions.
