Application for Constituent Network Charter

The _____ (the Applicant) does hereby apply for official recognition as a Constituent Network of The Association of Former Students of Texas A&M University (The Association).

By this application, we, the undersigned Charter members as organizers of this Constituent Network, pledge our full support to uphold the strong traditions of active Constituent Networks. We also understand and agree to the requirements for recognition and maintaining active status with The Association. The attached are submitted for approval by The Association and include the required Bylaws as set forth in the Constituent Network Model Bylaws.

As an officially recognized Constituent Network of The Association, the Applicant agrees to:

1. Operate under the Charter and Bylaws of The Association as it relates to the organization of this duly recognized Constituent Network.
2. Have the President or designee attend each of the semi-annual Association Leadership Council meetings.
3. Comply with the policies and procedures established by The Association related to the organization of this duly recognized Constituent Network.

The Applicant understands that failure to properly discharge the requirements of being a recognized Constituent Network may result in the Applicant's Constituent Network recognition being withdrawn by The Association. Similarly, the Applicant retains the right to withdraw as a recognized Constituent Network of The Association upon written notice to The Association.

The Applicant understands that the Constituent Network shall not be financially obligated to or by The Association of Former Students, nor shall The Association in any way be obligated or responsible for the financial affairs of the Constituent Network.

The Applicant understands that, subject to the foregoing, the Constituent Network retains full freedom of action, expression and program, with both the Constituent Network and The Association recognizing this Charter to be only a working and coordinating agreement for better accomplishment of our common goals.
