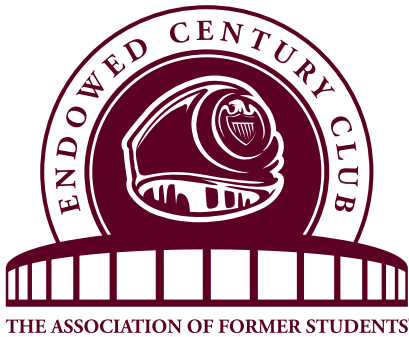


Endowed Century Club

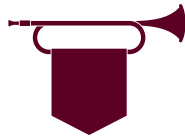

Frequently Asked Questions

Can I establish an Endowed Century Club membership in someone else's name?

Yes. The Endowed Century Club is a great way to commemorate anyone who shares a love for Texas A&M, either as a memorial or gift for any occasion (graduation, anniversary, etc.).

Will I still receive my annual Century Club year bars?

Yes. We will mail you an Endowed level year bar for your Century Club plaque annually, and you will receive a special Endowed Century Club decal.

My company has a matching gift program. Does this apply toward my endowment contributions?

Matching funds can be used to fund the endowment if criteria is met based on your company's matching gift policy. We encourage you to check the details of your company's matching gift program to see if you can multiply and maximize your impact on Texas A&M.
