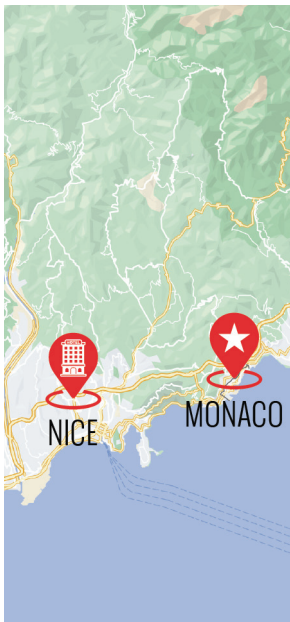

TRAVEL DAY Wednesday, May 24, 2023 - Recommended latest departure date from the United States
